Terms of Use & Privacy Statement

Karen Loves Country, LLC (“KLC”, “we,” “us,” “our”) hope you the user (“you,” “user,” “your”) find the blog at karenlovescountry.com (the “Blog”) useful and enjoyable. The following is intended to be a legally enforceable contract and also discloses how we use or may use your information. By continuing to use and/or access the Blog, you agree to these Terms of Use & Privacy Statement (the “Terms”), and each subsequent intentional access of the Blog likewise serves as your agreement to the Terms, whether or not such Terms are updated or different from those herein.

We offer this Blog as a service to you subject to the Terms. By accessing the Blog, and in consideration for the blog service that we provide to you (including at least access to content found on the Blog), you agree to abide by these Terms.
